### **Welcoming Staff Attorney Nam Mee Cho**



Catholic Charities Legal Network welcomes Nam Mee Cho as its new Staff Attorney, replacing Carolyn Ruyak.

Nam Mee's legal career has been focused on representing abused persons. She has experience in scaling up services to low-income individuals by leveraging the power of *pro bono* attorney support at private law firms.

After taking time off from practicing law to move abroad and raise her now-grown children, Nam Mee most recently served as Senior Staff Attorney at The Torture Abolition Survivors Support Coalition (TASSC), which was founded by Sister Dianna Ortiz, OSU and is located on the campus of The Catholic University of America. There, Nam Mee helped to re-start TASSC's asylum representation program for survivors of torture.

Nam Mee has worked or volunteered as an attorney at Catholic Charities Immigration Legal Services, Just Neighbors Legal Services, and Boat People SOS, as well as been an Equal Justice Works Fellow at Tahirih Justice Center. At Tahirih, she trained and supervised *pro bono* attorneys to represent individuals under the Violence Against Women Act. In addition, Nam Mee worked for five years at Polaris, an anti-human trafficking non-profit.

Nam Mee received her B.A. from Emory University in French Literature and Political Science, an M.A. from The University of Chicago in International Relations, and a J.D. from The George Washington University Law School. She is admitted to practice law only in Maryland; practiced supervised by D.C. Bar Members.

Beyond directing Catholic Charities Legal Network, Jim was also a family mediator in the Superior Court of the District of Columbia's Multi-Door Dispute Resolution Division for over 30 years. He has served on the Board of Governors of The John Carroll Society, the Civic Board of Directors of the Council for Court Excellence, and the District of Columbia Bar Foundation's Scoutt Prize Committee. Among Jim's honors include the Equal Justice Award from the University of the District of Columbia's David A. Clarke School of Law, the Bar Association of the District of Columbia's Suzanne V. Richards Award, the Jerrold Scoutt Prize from the DC Bar Foundation, The John Carroll Society Medal, The Archdiocese of Washington's 75th Anniversary Cardinal's Award, and Catholic Charities' Griffin Award.

Jim is *magna cum laude graduate* of Lincoln University in Pennsylvania. He was President of Lincoln's Alpha Chi Honor Society, and a graduate of Howard University School of Law. Jim holds a certificate from the University of Notre Dame Mendoza College of Business for completing the Nonprofit Business Excellence Program for Catholic Leaders. Jim is a member of the Knights of Columbus, Council 224. He is a member of the United States Supreme Court, District of Columbia, and Pennsylvania Bars.

### Legal Network Success Story: Brian Stolarz

A recent case demonstrates the critical representation that a Legal Network attorney can provide.

Norton Rose Fulbright US LLP Senior Counsel Brian Stolarz (left) and Associate Ian Slingsby (below, right) agreed to take on a case for a client who sought the aid of the Catholic Charities Legal Network to pursue a condominium warranty claim related to significant repairs needed after acquiring a low-income condominium unit that had serious construction defects. Brian and Ian were instrumental in facilitating a successful confidential resolution through mediation. The client was absolutely



thrilled with the result. The case demonstrated that when the balance of power in a case is brought to a level playing field, with both parties having counsel, the client feels empowered to pursue their claims and seek vindication.

We asked Brian Stolarz and Damarr M. Butler, two of our best volunteer attorneys, a few questions about what pro bono work through the Legal Network is like:

# Why is it important to accept pro bono civil law cases from legal services programs such as Catholic Charities Legal Network?

"It has been a true honor and blessing in my career to work on many pro bono cases from the Catholic Charities Legal Network. I believe that the law is a calling to use your talents for good, and there is no better way to do that than to accept a case from the Catholic Charities Legal Network. They screen the cases very well, and the clients are very much in need of assistance on critical matters to them and urgently need access to good counsel. "I went to Howard University School of Law, where we were taught that a lawyer is either a social engineer or a parasite on society. Along with being from Mississippi, when I received the call regarding possible representation, I felt a sense of urgency to assist someone with limited means that may have otherwise gone without representation in a very critical matter. # Is direct representation of a pro bono individual different from your practice in a large law firm?

"Obviously the work at a large international law firm involves complex cases for clients in various industries across the country and globe, and we are proud of the best of class service that we provide to our clients. The Catholic Charities Legal Network cases involve a case for an individual client facing an individual crisis whether in housing, public benefits, family law, or another kind of civil matter. I serve all clients with the same zealous advocacy and passion whether they are a large corporation or an individual from the Legal Network. That is the dedication you have to have as an attorney who seeks to be a servant leader for the causes of others." - **Brian Stolarz** 

"It depends. My practice is employee benefits, where I represent corporate clients in various ways, one of which includes representation before governmental regulatory agencies. Here, I represented an individual before a governmental agency regarding

entitlement to benefits. While the client entity may have been different, the avenues for relief were generally the same." - **Damarr Butler**
