

The Catholic Charities Legal Network continues to thrive in our community. It provides free legal services to those in our community who could not otherwise afford legal representation or advice. CCLN's great efforts to assist those in need has long been recognized and it is heartening to me to see the lengths to which members of CCLN go to provide the guidance and support to those so desperately in need. Our own chaplain Monsignor Peter J. Vaghi, Esq., who was instrumental in the establishment of CCLN, is being recognized as Clergy of the Year by the Catholic Business Network of Washington, DC. Msgr. Vaghi has dedicated his career to the service of others through his parish work, the John Carroll Society and CCLN. His guiding hand and prayerful direction have allowed CCLN to grow and prosper during his continuing tenure. We are all blessed to have his input and assistance. Dear Friends,

I completed my thirtieth year as Director of Catholic Charities Legal Network, as our program completed over thirty-five years of service to the public. I am pleased to report that in Fiscal Year 2024, the Legal Network assisted 1,789 individuals by providing direct legal representation and presenting legal education seminars in the District of Columbia and Maryland. I am also proud to report that our volunteers self-reported 2,733.50 pro bono hours valued at \$2,248,584.80.

Each year, the needs and number of our clients in the D.C. area seem to grow ever-larger, especially with issues of employment, domestic and custody disputes, landlord-tenant concerns, and looming consumer debt. Instead of despairing, we should see this as an opportunity to do more great work for these underserved groups. But our capacity to meet these needs is inhibited by the reduced size of our program's staff. Increased revenue is needed to hire additional staff attorneys, administrative assistants, and law student interns. Some progress has been made in this, such as the hiring of our valuable parttime staff attorney Nam Mee Cho, and I would like to thank the District of Columbia Bar Foundation for awarding us a grant to fund the bilingual paralegal position held by Emma Johnston on a full-time basis. Still, there is much work to be done.

Nevertheless, we have managed to serve a greater number of individuals this year than the last due to the hard work of our small team and our volunteers. When an expanded staff becomes available to us, it will combine with that spirit of diligence and service to the benefit of all those in need of legal aid.

In the face of all these challenges, the Legal Network still has many causes for celebration. First, we continue to be grateful for our selfless volunteers who give so freely of their time and use their legal skills to assist their neighbors in need. Thank you to those volunteers for conducting telephone and in-person intake weekly and monthly. Special thanks also to our government, solo, mid-size, and large law firm attorneys who accepted pro bono cases from the Legal Network, directly impacting lives for the better. We also thank the Catholic Charities Grants Department for helping us by writing major grants for the program, and the Development Office for helping us raise funds through contributions. Your help has been and will continue to be essential to the operations of the Legal Network. This past year, the Legal Network was blessed to have attorneys devote extraordinary amounts of time to the program and its clients. This includes Deacon Darryl A. Kelley, deacon at St. John

the Evangelist Church in Clinton, Maryland, and his zealous representation of clients on a pro bono basis in the Prince George's County court system, and Patrick J. Kennedy, a retired federal government attorney who assists the Legal Network staff on a weekly basis at our Hickey Center office in assessing each client's case.

I am especially appreciative of the Legal Network's staff for their commitment to serving the poor and underserved in our community.

Of particular importance to this program is the Legal Network Advisory Council.

I am grateful to all Council members and the Advisory Chairman, Andrew N. Cook, Esq., for their support and encouragement. I am also thankful for the continued support of the President and CEO of Catholic Charities, Jim Malloy.

Lastly, I am thankful for the financial support the Legal Network has received from its many donors and partners.

Though we have more work to do, I am proud of what we have been able to accomplish over the last year, and I invite you to peruse this report to learn more about our successes.

To provide access to the highest quality pro bono civil legal services to the poorest of the poor within the Archdiocese of Washington without regard to their religious affiliation.

2023 | 2024 Catholic Charities Legal Network's Impact

The support of volunteer attorneys from law firms, the government, and solo practices allows the Legal Network to fulfill its mission of offering free legal assistance to the poor. These volunteers provide pro bono legal representation and conduct intake with clients. Volunteer attorneys also monitor the Legal Network's telephone intake line and schedule clients for in-person intake, providing referrals when appropriate. Additionally, they present civil law seminars for low-income groups, and they mentor attorneys who handle pro bono cases.

The Legal Network assists families and individuals who earn at or below 250% of the Federal Poverty Guidelines. For an individual seeking the Legal Network's services in 2024, the income limit is \$37,650, and for a family of four, the limit is \$78,000. 1,789 low-income individuals were served in Maryland and Washington, DC during the fiscal year.



The Legal Network could not function without the hard work and dedication of its volunteers, who we thank for providing the bulk of our service in first and second stage intakes, the Advisory Council, and personally taking on the civil issues of clients. Among so many remarkable participants, we want to highlight the exceptional work of Steve Obermeier, Partner at Wiley Rein LLP, and Anita Stephen, Pro Bono Administrator at Crowell & Moring LLP, both of whom have coordinated pro bono legal services among their firms.

When Steve was first introduced to the telephone intake volunteering in the Legal Network, he took the initiative in getting his firm involved. He was quick to reach out to associates and paralegals in his firm, finding many who were enthusiastic about the idea, be it for gaining experience, becoming involved in the CCLN, or for the service opportunity itself. Anita has been doing the same since 2009 when she joined her Crowell & Moring's pro bono program. She said: "I coordinate our participation in CCLN's Hotline by advertising opportunities, setting up the shift schedules and sharing updates with our attorneys. I also submit conflicts checks, process the paperwork and send out retainer letters for pro bono cases referred to our firm by the Legal Network." Her efforts over the years have helped make Crowell one of the top contributors in pro bono hours and valuation.

Beyond just telephone intake, Steve used a similar system for delegating pro bono work among associates. By assigning a paralegal and staying involved in major stages of the cases, he was able to take on a great deal of pro bono work without undermining his commitments to his regular firm work. He stated that what stood out to him was both the positive interest he received on these projects and the effort that the firm's associates put into providing excellent legal service.

Anita found similar enthusiasm among the colleagues she introduced to the CCLN: "We present volunteering with the CCLN Hotline as a concise, easy way to participate in the Firm's pro bono program, but in fact the work is so much more. Attorneys find volunteering on the hotline deeply rewarding and are routinely reminded of the lasting impact of their conversations with callers to the Hotline. For many callers, the hotline is their first stop on a journey towards resolutions to challenging situations including landlord/tenant disputes, domestic violence, custody cases and immigration-related inquiries."

One of the most rewarding parts of this work is how it affects the lives of individuals in need in so many unique ways. When asked about his favorite pro bono cases, Steve recalled mediating between a woman and her landlord over mold that posed a major health risk to her. Another involved helping a paraplegic man regain his state provided nurse after he was incorrectly evaluated to not need the help. He continues to have these amazing experiences, being struck by the amount of good that is done by simply spending time with the clients and their families.

Reflecting on the experience of service, Steve said that his Catholic Faith was a major part in his undertakings, with his hope being to "never say no when asked, be that by his Church or Jim." He specifically asked that the firm and associates he recruits be given recognition for the time and work they put in: "It has truly been a team effort." Anita likewise stated that "Catholic Charities Legal Network occupies a special place in my heart. I admire the work CCLN does and am grateful to play a small role in advancing and facilitating that important work." The Legal Network is deeply grateful for the efforts of them and their firms.

James D. Bishop, Esq. Director, Catholic Charities Legal Network

Jim's entire professional career has been serving low-income and homeless residents for close to forty years. Prior to accepting the position as Director of Catholic Charities Legal Network of DC in December 1993, he was employed for eight years at the mandatory District of Columbia Bar in several public interest positions. Jim has directed



Catholic Charities Legal Network for over 30 years. He is a parishioner of Saint Patrick's Catholic Church in downtown DC and a third generation native Washingtonian. Jim was a family mediator in the Superior Court of the District of Columbia's Multi-Door Dispute Resolution Division for over 30 years. He has served on the Board of Governors of the John Carroll Society, the Civic Board of Directors of the Council for Court Excellence, and the District of Columbia Bar Foundation's Scoutt Prize Committee. Among Jim's honors include the Equal Justice Award from the University of the District of Columbia's David A. Clarke School of Law, the Bar Association of the District of Columbia's Suzanne V. Richards Award, the Jerrold Scoutt Prize from the DC Bar Foundation, the John Carroll Society Medal, the Archdiocese of Washington's 75th Anniversary Cardinal's Award, and Catholic Charities' Griffin Award. While Jim has been at the helm of Catholic Charities Legal Network, the program has assisted approximately 85,000 low-income and homeless District of Columbia and Maryland residents with a variety of civil law cases such as child custody, Social Security, and bankruptcy matters. He has made sure that residents are educated about their legal rights in such areas as consumer/fraud, child custody, and wills and advanced medical directives by conducting seminars at local churches, senior citizen organizations, transitional and low-barrier shelters. Jim is a magna cum laude graduate of Lincoln University in Pennsylvania. He was President of Lincoln's Alpha Chi Honor Society, and a graduate of Howard University School of Law. Jim holds a certificate from the University of Notre Dame Mendoza College of Business for completing the Nonprofit Business Excellence Program for Catholic Leaders. Jim is a member of the Knights of Columbus, Council 224. He is a member of the United States Supreme Court, District of Columbia, and Pennsylvania Bars.

Deacon Darryl A. Kelley, Esq. Staff Attorney, Catholic Charities Legal Network

Deacon Kelley is a resident of Prince George's County and has a law practice in Camp Springs, Maryland. Deacon Kelley began accepting pro bono matters from Catholic Charities Legal Network (CCLN) in 2018. His cases for CCLN involve family, estate, landlord/tenant, and bankruptcy matters. He currently serves as deacon at



St. John the Evangelist Catholic Church. He also serves as a Public Policy Advisor for the Archdiocese of Washington's Public Policy Team. He is a former Maryland State Delegate for the 26th Legislative District and previously served as Legislative Assistant for Education and Labor to former United States Senator Paul S. Sarbanes. 

Johnston, our bilingual paralegal, works at the D.C. Superior Courthouse twice a month to provide these brief information and referral services in both English and Spanish. She has been most active in the landlord/tenant and family divisions, making referrals to resources within the Court and other programs throughout the city. Even after arriving at the court, finding the help they need can be difficult task for those unfamiliar with the daunting system. Emma Johnston aids in navigating them to the proper resources to get them assistance with their legal matters. For example, after speaking to a person seeking assistance in a custody matter, she would direct them to the Family Law Division, where they can be referred to services such as the D.C. Superior Multidoor Dispute Resolution Program, the Legal Aid Society of D.C., the Neighborhood Legal Services Program, or the CCLN. This program is completely new to the Legal Network, and we hope it continues to grow and serve D.C. residents in the coming years.

On Thursday, June 20th, 2024, John E. McCarthy, Honorary Chairman Emeritus of the Advisory Council, was honored with the D.C. Bar's 2024 Laura Rinaldi Pro Bono Lawyer of the Year Award. The D.C. Bar states: "The award is presented to a lawyer for excellence, achievement, and commitment to providing legal services to the District of Columbia's low-income and/or disadvantaged individuals and/or organizations serving such individuals." He was recognized at this year's D.C. Bar Celebration of Leadership at the Westin Washington, D.C. Downtown Hotel. Mr. McCarthy has been a longtime volunteer attorney with the Legal Network. He has accepted pro bono cases from the Legal Network in such areas as child custody and consumer matters, as well as assisting the staff with legal ethics issues. He has been a valued member of the Advisory Council, the Golf Tournament Committee, and accepts pro bono cases from the Legal Network. In his letter recommending John for the award, director Jim Bishop wrote: "for the past 30 years, I have worked with more than five hundred individual volunteer lawyers. John E. McCarthy Jr. stands out in front of them all as the rare volunteer that always says "Yes" when a pro bono client needs help."

One of our chief causes of celebration this year is the exceptional work of our volunteer attorneys, whose contribution of pro bono hours and value has greatly exceeded last year's. At a final count of 2733.50 hours valued at \$2,248,584.80, it marks a 11% increase in hours and a 25% increase in dollar value submitted by a similar number of volunteer attorneys and firms over the prior fiscal year. We are ecstatic about this display of charitable spirit and good service for underserved clients, and we hope to bring in more volunteers this new fiscal year to affect them with this same joy.



The 39th annual Catholic Charities Gala was held on Saturday, April 20th at the Washington Hilton, raising \$3.150 million and hosting nearly 1,000 attendees. We welcomed 30 first time gala donors who either sponsored a table or purchased individual tickets. 13 parishes who have not historically participated in the gala attended this year. The Fund the Mission gave guests a chance to financially support the mission of CCADW, raising over \$185,000 and resulted in new donors to the agency.



Thank you to Miller & Chevalier Charitable Foundation for their continued outstanding support of our work here at CCLN in fiscal year 2024. Among their contributions are providing funding for our attorneys' licenses and for director Jim Bishop to attend the Equal Justice Conference.


